ITAL 444C – Feelings: A History – HUMA/INQ/WI

The DC expressed positive feedback overall, but concern that the syllabus did not contain Student Leaning Outcomes (SLO's) as required by NECHE or follow Inquiry guidelines. Also, would course title create confusion for students who might assume the course satisfies Historical Perspective rather than Humanities? The committee is requesting that SLO's be added, to make the Inquiry course features more explicit, and to consider tweaking the title. Nicky will communicate with Honors and request a resubmission.

# III. <u>Discussion</u>

- Online D-Lab update: The subcommittee met on October 5<sup>th</sup>. Nicky is working on writing an objective report that addresses concerns and includes best practices if the Faculty Senate lifts the moratorium permanently.
- Early Alert Progress Report update: The Early Alert is sent out in week 5 and the drop deadline is the end of the fifth week. There is concern this is not enough time for students to drop a course they did not realize they were failing. Andy advised the committee that moving the drop deadline to later in the semester is problematic. It would have implications for Financial Aid and Business Services and the university has to comply with federal guidelines. Moving the alert earlier in the semester is also problematic as many courses will not have had enough time to get an accurate assessment of a student's performance.
