III. Discussion

<u>DRC Proposal for Revised Discovery Program</u> – Nicky updated the DC on the results of a recent Faculty Senate survey about the DRC proposal and concerns raised regarding impact the proposed program would have on heavily prescribed majors; accusations that the proposal is "COLA-centric," and more. There was also discussion of the CEPS ETS variance agreements – how they work now and how they were developed – and if they could/would remain in place under the new program. The variances could remain or be revised. This is something Discovery would work on with the departments and CEPS. Discussion of the proposed first-year diversity requirement included the possibility that if the DRC's proposal is voted down by the Senate, it is likely a separate motion to add the diversity requirement will be put forward.
