- ETS Pathways in Engineering: The committee discussed the agreement that allows ETS to be fulfilled by
  a suite of courses for certain CEPS students and the challenge that some face when they either test out
  of a course or transfer a course in. Nicky will consult with the Associate Dean of CEPS to discuss
  potential adjustments to the agreement to reduce the need for student petitions and report back to the
  committee.
- Other potential changes, i.e., make fulfilling FPA easier for Music majors, will be discussed once the GERC recommendations are released.
- National Survey for Student Engagement (NSSE): Comments from the NSSE, a survey administered to graduating seniors, that reference Discovery were shared with the committee. The comments were overwhelmingly negative and often mentioned the requirements are not flexible enough.
