National Surveys of Children's Exposure to Violence

Since 2002, David Finkelhor, Heather Turner and I have conducted 4 nationally representative studies on youth victimization, co-sponsored by the Office of Juvenile Justice and Delinquency Prevention and the Centers for Disease Control. These are the U.S.'s primary surveillance of victimization against youth that is not reported to authorities, including the only nationally representative figures for numerous forms of victimization, including statutory rape, exposure to shootings and riots, and several other forms of victimization, crime, and abuse.
