NH STAYING HOME FOR CHRISTMAS

DURHAM, NH – Most Granite Staters will stay at home over the holidays – either as a "staycation" or working. If they have a Christmas tree, it will likely be a real tree. And to complete the traditional New England Christmas scene, most think we will have snow at Christmas.

These findings are based on the latest **WMUR Granite State Poll**,* conducted by the University of New Hampshire Survey Center. Five hundred and fifty-four (554) randomly selected New Hampshire adults were interviewed by landline and cellular telephone between November 22 and November 25, 2013. The margin of sampling error for the survey is +/- 4.2 percent.

Holiday Travel Plans

Most New Hampshire residents (84%) will not go away on vacation for the holidays - 46% don't get any vacation time and 38% have vacation time but plan to stay at home. Only 14% of Granite Staters plan to go out of town on a vacation -2% will vacation somewhere in New Hampshire, 4% in another New England state, 6% in a state outside New England, and 2% in a different country.

Households earning between \$60,000 and \$100,000 are more likely to not have any vacation time this holiday season while households earning less than \$30,000 and Connecticut Valley residents are more likely to stay at home.





Real or Artificial Christmas Tree?

Christmas tree farms are a common sight in New Hampshire, but just over half of New Hampshire households (52%) plan to have a real Christmas tree in their home this year, 35% will have an artificial tree, 3% will have both, 10% will have no tree and 1% are unsure. The percentage of households who plan to have a real Christmas tree has dropped 10 percentage points since 1999.

Households earning between \$30,000 and \$75,000, households with two or more children and residents of the North Country or Connecticut Valley are more likely to put up a real tree in their home. Households earning less than \$30,000 and residents in the Manchester Area or along the Mass Border are more likely to put up an artificial tree. Older residents (65 and over) or those who are divorced or separated are more likely to not put up a tree at all.


Real or Artificial Christmas Tree



White Christmas

More than four in five New Hampshire residents (81%) are expecting a white Christmas this year, 13% are not expecting a white Christmas and 6% are unsure. The percentage expecting a White Christmas in New Hampshire has been unchanged since 1997.

Granite State Poll Methodology

These findings are based on the latest WMUR Granite State Poll, conducted by the University of New Hampshire Survey Center. Five hundred and fifty-four (554) randomly selected New Hampshire adults were interviewed by landline and cellular telephone between November 22 and November 25, 2013. The margin of sampling error for the survey is +/- 4.2 percent.

The data have been weighted to adjust for numbers of adults and telephone lines within households, respondent sex, age, and region of the state. In addition to potential sampling error, all surveys have other potential sources of non-sampling error including question order effects, question wording effects, and non-response.
